Circular Letter No. 98-1310

RE: ITEM B-1352 Fertilizer Dealers & Manufacturers

The Minnesota Department of Commerce has approved the above filing effective 12:01 a.m., January 1, 1999, applicable to new and renewal business only.

The purpose of the above referenced filing is to enhance classification phraseologies and footnotes for Code 4583 - Fertilizer Mfg. & Drivers; Code 8215 - Hay, Grain or Feed Dealer & Local Managers, Drivers; and Code 0050 - Farm Machinery Operation—By Contractor & Drivers. It is anticipated that clarifying the current classification phraseologies that relate to the manufacturing, sale, and application of feed, fertilizers, grain, and hay will better facilitate the classifying of employers within this industry.

Currently, Minnesota classifies the sale and distribution of Anhydrous Ammonia under Code 8353. To facilitate the continued use of Code 8353 for these purposes, special language has been created in the Minnesota exception pages of the Basic Manual to specify the exclusion of Anhydrous Ammonia sales under Codes 4583, 8215, and 0050.

The attached exhibit outlines the changes required in the Basic Manual necessary to implement Item B-1352. Please note that the language in these pages contains underlined and strikethrough text. The underlining represents new or added text while the strikethroughs indicate deleted text. Special Minnesota language or exceptions have been added or amended as applicable. The National Council's original filing memorandum is also attached for your review.
